# COTTER CITY COTTER COUNCIL MINUTES July 22, 2021 6:00 p.m. COUNCIL CHAMBERS

The regular meeting of the Cotter City Council was called to order at 6:00 p.m. by Mayor Caradine. He asked for roll call by Recorder/Treasurer Andrea Kray. Present were: Council Members Chuck Sugg, Carolyn Gill, Cameron Ross, Mertice Kray, Linda McCarthy, and Mark Johnson.

The invocation was given by Councilman Cameron Ross followed by the recitation of the Pledge of Allegiance by all present.

### REPORTS

Approval of the May 27, 2021, regular minutes was the first item of business. Councilman Cameron Ross moved to accept the minutes as written from Recorder/Treasurer Andrea Kray with a second provided by Councilman Chuck Sugg. **Motion passed unanimously.**

### **UNFINISHED BUSINESS**

In the first order of Unfinished Business, USDA grant was approved in the amount of \$25,000 for the purchase of fire department turnouts. The funding will be deposited next month with a line item add to the 2022 budget for this expenditure.

In the second order of Unfinished Business, USDA Grant for the purchase of a Case Backhoe for the Street Department is pending. A trade value has yet to be determined. Once the trade value is determined, funding will be placed in a line item for the 2022 budget for this expenditure.

### **NEW BUSINESS**

In the first order of New Business, Jason Nazarenko with the Cotter Gassville Chamber of Commerce presented the City of Cotter with a check in the amount of \$4000.00. These funds were raised at the F3T Fly Fishing Film Tour and will go back in projects to help promote and beautify the Big Spring Park as well as other areas of the City of Cotter.

In the second order of New Business, North Arkansas Youth Center board members Mark Kapshandy and Chris Francis asked Council to consider passing a resolution to apply for an Arkansas Community Development grant for the multiple use courts. Mark Kapshandy read a letter addressed to Council and provided them with a bank statement of the youth center board's current fundraising account. This grant will allow improvement to the facilities which will in turn allow for future fundraisings opportunities to better sustain themselves. The current project includes updating the multiple use which will have 3 basketball courts, 2 pickleball courts, and a full sized tennis court. Tina Cole from the NWAEDD also addressed Council on behalf of the NAYC stating that the project is favorable and the project has merit with a good outlook. She has assisted with grants in the past and states this grant is a 50/50 matching grant of \$15,000. The youth center is appropriating \$18,000 for this grant application.

In the third order of New Business, Mayor Caradine had Recorder/Treasurer Andrea Kray read Resolution 2021-14: a Resolution for an Arkansas Community Development Grant for NAYC Multiple Use Courts. Councilwoman Carolyn Gill asks for a clarification on the word "appropriates" and Tina Cole discusses the meaning of the word in the grant application. Councilwoman Mertice Kray moves to pass Resolution 2021-14: a Resolution for an Arkansas Community Development Grant for NAYC Multiple Use Courts with a second provided by Councilman Cameron Ross. **Motion passed unanimously.** 

In the fourth order of New Business, Mayor Caradine had Recorder/Treasurer Andrea Kray read Resolution 2021-15 - A Resolution to enter into agreement with Northwest Arkansas Economic Development District for Administrative Service for American Rescue Plan. Councilman Chuck Sugg moves to pass Resolution 2021-15 - A Resolution to enter into agreement with Northwest Arkansas Economic Development District for Administrative Service for American Rescue Plan with a second provided by Councilwoman Carolyn Gill. **Motion passed unanimously.** 

In the fifth order of New Business, Mayor Caradine presented Ordinance 2021-04 - An Ordinance amending the Municipal Code to add Chapter 8.24 - Recreational Vehicles. Mayor Caradine asked Jason Nazarenko to recap the discussion pertaining to the Ordinance to Council members that weren't able to be at the workshop. Councilman Chuck Sugg asks for clarification on items 1-7 under section B "Habitation". He would like to eliminate the entire section. Recorder/Treasurer Andrea Kray asks Mayor Caradine how he was proceeding with the passage of the ordinance and if emergency passage was not on the agenda, then any and all corrections or amendments could wait until Council considers the Ordinance for passage in 3 months' time. Councilman Cameron Ross moves to have Ordinance 2021-04 - An Ordinance amending the Municipal Code to add Chapter 8.24 - Recreational Vehicles placed on its first reading by title only with a second provided by Councilwoman Mertice Kray. Motion passed unanimously. Recorder/Treasurer Andrea Kray read Ordinance 2021-04 - An Ordinance amending the Municipal Code to add Chapter 8.24 - Recreational Vehicles on its first reading by title only. Ordinance 2021-04 - An Ordinance amending the Municipal Code to add Chapter 8.24 - Recreational Vehicles will be placed on its second reading by title only at the August 2021 Council meeting.
