City Council of Cotter, Arkansas

A RESOLUTION TO SET TAX LEVY (MILLS) ASSESSED IN 2022 TO BE COLLECTED IN 2023.

WHEREAS, funds for payment of expenses incurred by the City of Cotter, Arkansas in the year 2022 need to be allocated and assessed and,

WHEREAS, taxes on property in the City of Cotter, Arkansas collected by the Baxter County Collector provide most of that funding and,

WHEREAS, the City Council of the City of Cotter, Arkansas shall set the millage rate to be levied (assessed) in the year 2022 by the Quorum Court of Baxter County on property within the City of Cotter, Arkansas and collected in the year 2023.

THEREFORE, BE IT RESOLVED, the City Council of the City of Cotter, Arkansas, hereby requests the following tax millage be fixed by the Quorum Court of Baxter County:

1. A 5-mill tax for the general operation of said City.
2. A 4-mill tax for the operation of the Fire Department of said City.

BE IT FURTHER RESOLVED, the Mayor and Recorder/Treasurer of the City of Cotter, Arkansas are hereby authorized and directed to request the Honorable Mickey Pendergrass, Judge of Baxter County and the Quorum Court of Baxter County, Arkansas levy said tax rates on property in the City of Cotter, Arkansas at their regular meeting in November per Arkansas Code Annotated 4-14-904.

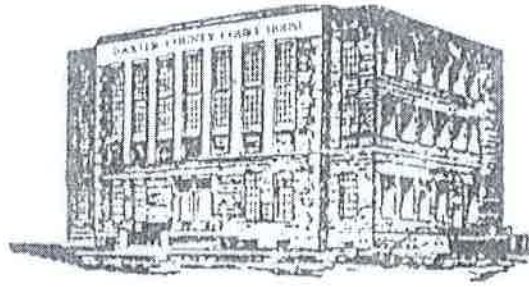
