COTTER CITY COUNCIL REGULAR MINUTES COUNCIL CHAMBERS

March 23, 2023 -- 6:00 p.m.

The regular meeting of the Cotter City Council was called to order at 6:00 p.m. by Mayor Caradine. He asked for roll call by Recorder/Treasurer Andrea Kray. Present were: Council Members Chuck Sugg, Shelia Wingard, Carolyn Gill, Mertice Kray, and Linda McCarthy. Cameron Ross was absent.

The invocation was given by Councilwoman Mertice Kray followed by the recitation of the Pledge of Allegiance by all present.

REPORTS

Approval of the February 23, 2023, regular minutes was the first item of business. Councilwoman Mertice Kray moved to accept the minutes as written from Recorder/Treasurer Andrea Kray with a second provided by Councilwoman Carolyn gill. Motion passed unanimously.

NEW BUSINESS

In the first order of New Business, Mayor Caradine had Recorder/Treasurer Andrea Kray read the resignation letter of Cameron Ross from Ward 3, Position 2. Councilman Chuck Sugg moved to accept the resignation as read with a second provided by Councilwoman Shelia Wingard. Motion passed unanimously. Mayor Caradine announced the open position and asked any interested persons to please contact him if interested.

In the second order of New Business, Council considered Ordinance 2023-02: An Ordinance to follow recommendations by Arkansas Rural Water Association 2022 Sewer Rate Study to increase customer sewer rates annually starting in 2024. Councilwoman Mertice Kray moved to have Ordinance 2023-02 read in its entirety with a second provided by Councilman Chuck Sugg. Mayor Caradine entertained a comment from the audience at this time by Kay Laughry. She questioned why the City of Cotter is going forward with this ordinance and its time frame. Mayor Caradine stated it was at the recommendation of the sewer rate study to ensure that the inflation was accounted for and that the sewer department could successful cover its operating expenses in the years to come. Motion passed unanimously. Recorder/Treasurer Andrea Kray read Ordinance 2023-02 in its entirety.

Councilwoman Shelia Wingard moved to place Ordinance 2023-02: An Ordinance to follow recommendations by Arkansas Rural Water Association 2022 Sewer Rate Study to increase customer sewer rates annually starting in 2024 on its second reading by title only with a second provided by Councilman Chuck Sugg. Motion passed unanimously. Recorder/Treasurer Andrea Kray read Ordinance 2023-02 by title only.

Councilwoman Mertice Kray moved to place Ordinance 2023-02: An Ordinance to follow recommendations by Arkansas Rural Water Association 2022 Sewer Rate Study to increase customer sewer rates annually starting in 2024 on its third reading by title only with a second provided by Councilwoman Linda McCarthy. Motion passed unanimously. Recorder/Treasurer Andrea Kray read Ordinance 2023-02 by title only.

Councilwoman Shelia Wingard moved to pass Ordinance 2023-02: An Ordinance to follow recommendations by Arkansas Rural Water Association 2022 Sewer Rate Study to increase customer sewer rates annually starting in 2024 with a second provided by Councilman Chuck Sugg. Motion passed unanimously.

Councilwoman Mertice Kray moved to pass Ordinance 2023-02: An Ordinance to follow recommendations by Arkansas Rural Water Association 2022 Sewer Rate Study to increase customer sewer rates per 4%annually starting in 2024 as an emergency with a second provided by Councilwoman Linda McCarthy. **Motion passed unanimously.**

In the third order of New Business, Mayor Caradine sought Council's approval to move forward on the construction of the sidewalks in the Big Spring Park based on the grant funding received. Councilwoman Mertice Kray with a second provided by Councilman Linda McCarthy. **Motion passes unanimously.**

In the fourth order of New Business, Council considered Resolution 2023-03: A Resolution establishing a Cotter City Council Member Code of Meetings and Activities. Councilman Chuck Sugg moved to pass Resolution 2023-03: A Resolution establishing a Cotter City Council Member Code of Meetings and Activities with a second provided by Councilwoman Mertice Kray. **Motion passes unanimously.**

During information, Mayor Caradine shared that the 2022 Financial Statement for Cotter has been posted for 30 Days (Proof of Posting) and that the Annual Cash Flow Financials for Year 2022 Municipal Funds and Water Department Funds shall be posted for 30 days at Cotter City Hall and the Cotter Post Office. There is a Vacancy on City Council and those interested should contact the Mayor prior to April 21, 2023. The City of Cotter was recognized by the Arbor Day Foundation as a 2022 Tree City USA. The Annual Cotter Trout Festival is May 6, 2023. The F3T Fly Fishing Film Tour May 27, 2023, and the Cotter Fly Casting Contest May 27, 2023.
