The regular meeting of the Cotter City Council was called to order at 6:00 p.m. by Mayor Caradine. He asked for roll call by Recorder/Treasurer Andrea Kray. Present were: Council Members Carolyn Gill, Mertice Kray, Chuck Sugg, and Linda McCarthy. Absent was: Shelia Wingard.

The invocation was given by Councilwoman Mertice Kray followed by the recitation of the Pledge of Allegiance by all present.

NEW BUSINESS

With no other interested applicants, Councilwoman Mertice Kray moved to appoint Ben Woodard to fulfill the remaining Alderman term for Ward 3, Position 2 with a second provided by Councilman Chuck Sugg. **Motion passed unanimously.** Mayor Caradine then proceeded to swear Ben Woodard into office. This term will end on December 31, 2024. Ben Woodard join the rest of the Alderman on the Council bench and finished the meeting as a voting member of Council.

In the second order of New Business, Jason Nazarenko addressed Council pertaining to the F3T Fly Fishing Film Festival. This year's festival will take place earlier in the evening and he is working on a new digital screen instead of using the bridge support beams. He is seeking Council's consideration of a resolution at next month's meeting for a one-time request to have a beer garden at the festival.
